

PERMISSIONS FOR USE

Educational Use: Members have permission to use this script for acting classes, workshops, general auditions, school entrance auditions, personal practice, and school-related performances.

Film and Video Productions: Members have permission to film or record a performance of this script for the purpose of demonstration (demo reel or show reel) as long as the companies name appears in the film/video credits in the finished production. The credit shall be identified as "Written by Training Sides." If no credits are presented in the finished product, then no writer's name needs to be given.

Promotional Use: At no time are the sides from the membership page permitted to be posted on any online/internet platform. Legal action will be made to the owner of the website who posts the original copyrighted content. Legal action will be made to the owner of the post, should screenshots or PDF's be shared and uploaded through social media platforms (Facebook, Instagram, Twitter, etc.)

Expansion & Development: Members have permission to expand or develop these training sides into a short film, feature, or any sort of episodic series for commercial use or for entries into film festivals and competitions where a monetary award or prize is offered, in which case, monetary compensation may be required by the writers.

NOTE: Most film festival organizations and their sponsors may not even allow a produced video/film of our scripts to be entered, since there may be a duplication of this script by other creatives. It is our advice for filmmakers to only submit original material to film festivals.

EXT. APARTMENT BUILDING - NIGHT

A hand uses the door knocker. No answer. They knock on the panel of the white door.

A TENANT opens the door.

TENANT

Yeah?

A DETECTIVE IN A BLAZER stands outside.

BLAZER

I just need another minute of your time.

TENANT

You didn't get enough of me from earlier today?

BLAZER

Just a quick follow up.

An colicky baby is overheard crying in the back of the apartment. The Tenant glances towards the baby, yet ultimately ignores the sounds.

BLAZER (CONT'D)

When you said you hadn't seen your neighbor for days, did that include last night?

TENANT

Yeah. Why?

BLAZER

I have video from-

TENANT

-Somebody should pick the baby up! I can't even think with all that noise!

(turning back)
What were you saying?

BLAZER

I saw you talking to your neighbor's husband last night. Got the video from the landlord--

TENANT

--I don't recall that we spoke.
 (turning back to inside
 the apartment)
 (MORE)

TENANT (CONT'D)

Can someome get the baby? It needs a bottle or something.

BLAZER

Look, I just need an official answer--for the record. Did you talk to your neighbor or not? I'm getting conflicting statements.

TENANT

I don't recall. It sounds like you need a warrant.

BLAZER

Sounds to me like you need a lawyer.

TENANT

Is that so?

The Detective shifts, tranquilizing the situation.

BLAZER

Look, I'm not playing hardball. Just trying put some puzzle pieces together.

The baby continues to scream, still unattended.

TENANT

I need to get back inside.

BLAZER

Unfortunately, we'll probably be doing this again.

The Detective sighs and turns back towards their SUV.

TENANT

That sound is birth control. Am I right?

The Detective offers up a forced smile.
